

What we discovered:

- Gliding is (by far) the top CASC sport
- The costs aren't hidden
- Gliding is more affordable than we thought
- Clubs have designed a whole range of
 - Flying packages & products
 - Pricing schemes

Flying packages and products



Examples of existing club packages and products

Bulk buy of launches or flying fees for a 20 - 25% discount

Free or reduced charges at times when demand on club facilities is lower

Concessions on membership, launch fees and flying fees for:

Juniors (under 26) – with some clubs providing free flying fees

Students

Elderly (over 65)

Families

Fixed price to solo membership & training packages

Fixed price bundles of launches and flying fees at discounted rates

Hosting University Gliding Clubs as affiliated clubs, giving reduced cost flying for students

Block membership for specific groups such as schools

A fixed fee for flying club gliders of £350pa, regardless of the time spent flying (membership and launch fees to pay on top) – this rewards the keenest pilots

Caps on launch and flying fees in a day

Reduced soaring fees

Specific young person, disabled and schools schemes

Discretionary scholarships and bursaries – often funded from legacies and gifts

Midweek discounts (open to all members)

Winter soaring ticket, and other season tickets (similar to bulk buy schemes)

Free flights for young pilots, on specific schemes, sometimes in exchange for helping around the club and supporting flying activities
