## Air Pilots/BGA Young Gliding Instructor Bursary Application

### Before going any further, please read this!

Instructing is a hugely rewarding activity and there's no doubt that the training that leads up to an instructor qualification improves any pilots flying skills and knowledge. And instructing doesn't need to get in the way of other gliding. Here's a view from a British Gliding Team member;

"I can highly recommend getting an instructor rating as a fun way to expand your gliding experience. My summer working as a BI really helped me to appreciate the 'other' side of gliding to cross country racing, and the two sides can work great in tandem. I have done many mornings instructing then jumped in a single seater to do a 300km task in the afternoon. It also gives you the chance to show people this awesome sport, and there isn't much better than seeing the grin on someone's face after giving them their first taste of flight!"

As you'd expect, instructor training does result in cost. The good news is that there are two instructor qualifications that an Honourable Company of Air Pilot young instructor bursary can support. Assistant instructor applications will be prioritised.

<u>Basic Instructor.</u> The course is arranged at club level, usually between the CFI and regional coaching and examining team. Where approved, a £500 bursary is paid to the club where the course takes place.

### Assistant Instructor. This course is arranged in modules;

- Teaching and learning (the A module) usually during a winter weekend in a briefing room.
- Club based training (the B module) delivered over whatever period works for you at your club. A £375 bursary is paid to the club where the club-based training takes place.
- Progress check (the C module) where one of the BGA approved coaches makes sure you are ready for the final bit of the course
- Instructor training on a 5-7 day course (the D module) delivered by approved BGA coaches. **A £400 bursary is paid to the club where the training takes place.**

There is no course fee payable to the BGA by successful bursary applicants.

### Notes to applicants

- a) Please ensure that you take care completing this application. If you feel something doesn't apply to you, please indicate so rather than leave a blank space.
- b) To apply for a bursary, you must be a member of a British Gliding Association gliding club, you must meet the requirements for training for the relevant BGA instructor rating, and you must be recommended for instructor training by your CFI. BGA instructor requirements are detailed at <a href="https://members.gliding.co.uk/library/bga-requirements-guidance/instructor-requirements/">https://members.gliding.co.uk/library/bga-requirements-guidance/instructor-requirements/</a>.
- c) You must be at least 16 and under 25 years of age on application.
- d) On completion of the instructor training you must supply the BGA with a brief written report that can be used to inform the bursary funders.
- e) When sections 1&2 have been completed, please ask your Chief Flying Instructor to complete section 3.
- f) You should submit the completed application by post or email (details below).
- g) The BGA will at its sole discretion select the successful applicants.
