Safety

Aerotow Performance. The BGA has published a new safety briefing highlighting the factors affecting aerotow take-off performance. This incorporates lessons learned from an accident during 2015 (which, thanks to prompt spin recovery action by the pilot, resulted in a repairable glider and no injuries), a BGA review of other aerotow incidents and available guidance, and consultation with a significant number of very experienced pilots and instructors. Occurrence Reporting. The BGA accident and incident reporting system contributes to reduced risk in gliding by ensuring that relevant information is reported, collected, carefully analysed and acted upon. You may be aware that the CAA operates a Mandatory Occurrence Reporting (MOR) scheme with the same objective but which is primarily designed for aeroplane operators and rarely results in analysis. A new European Regulation will soon result in changes to CAA CAP 382 to include revised lists of occurrences that must be reported to the regulator. The BGA will, in due course, provide advice on any necessary changes to reporting accidents and incidents to gliders. Until then, clubs and pilots reporting a gliding incident or accident should continue to follow BGA reporting requirements including the existing BGA accident and incident reporting form (see https://members.gliding.co.uk/?p=16120 and https://members.gliding.co.uk/?p=16694 respectively). Meanwhile, all clubs and pilots are reminded that the CAA MOR scheme can be used for reporting 'any incident which endangers or which, if not corrected, would endanger an aircraft, its occupants or any other person'. A number of clubs use MORs to report close encounters between passing aircraft and winch cables that don't qualify as an Airprox. It's helpful if these events are reported. Airworthiness Directives. BRP Powertrain (Rotax) 912/914 Engine Cylinder Head – Inspection / Replacement. EASA has issued AD 2015-0240 requiring a one-time inspection to determine the actual engine configuration and, depending on findings, engine re-identification and (depending on TC or STC holder installation) modification of the affected aircraft. Tom is the new world champion in the Club Class following two weeks of great soaring which also saw team mate Sam Roddie take bronze. Solid performances in the Standard Class (Matt Davis 10th and Mike Gatfield 15th) also gave Team GB bronze medal position in the Team Trophy. BAeA Glider Trophy Results. The British Aerobatic Association has announced the final results in its season-long Glider Trophy. Juniors

Honourable Company of Air Pilots Scholarships. Applications are now open for 2016 scholarships under the Honourable Company's Flying Scholarships Programme. This year, a number of gliding scholarships are being offered to people over the age of 16 to give the successful candidates the opportunity to fly on a one week residential course at a BGA Junior Gliding Centre. This course could take a candidate to first solo. Courses will take place on 25th-29th July and 13th-19th August 2016. The selection process will include an interview at which candidates will be asked to confirm their preferred course dates.
