General

BGA Conference and AGM. Child Protection. The BGA Child Protection Policy and Procedures document/template has been updated as the Jan 18 version. The update includes Child Protection Officer's responsibilities to check the DBS's and to take appropriate action. https://members.gliding.co.uk/club-development/child-protection/

GDPR. The EU's General Data Protection Regulation (GDPR) comes into force during May 2018. We are advised that the GDPR aims to give people more control over how their personal data is used, and to give businesses a simpler, clearer legal environment in which to operate by making data protection law identical throughout the single market. Exhibitions. Our awesome volunteer BGA PR team will be attending a select number of major exhibitions this year with the simulator. Marketing Officer. Following a longer than expected process of assessing some very strong applications, we look forward to announcing the appointment of a BGA Marketing Officer during February.

TMG's and the Sailplane Opt-Out. The BGA has been working with the CAA GA Unit to ensure that UK pilots who fly EASA sailplanes that are TMG's (eg Grob109, Falke, etc) are included in the EU's planned sailplane and balloon opt-out from EASA licensing rules from 8 April 2018 to 8 April 2020, when it is expected that simpler, proportionate rules for sailplane pilots will have been established. Whilst there is an expectation that TMGs (a type of powered sailplane) will be included in the opt-out, which will enable pilots to continue to use NPPL SLMG privileges until 2020, the CAA are unable to confirm that until the EU has published the sailplane opt-out requirements. Pilots of non-EASA aircraft are of course unaffected by EASA licensing requirements. Funding

Royal Aero Club Trust Bursaries. The Royal Aero Club Trust, as part of its Flying for Youth program administers a Bursary Scheme for young people. The scheme includes flying

bursaries/grants for those wishing to advance from one recognised level of air sport to the next higher level and wish to upgrade their existing qualifications, as well as advanced Bursaries to enable well qualified air sports persons enter international or national competitions or other prestigious events or to advance their existing qualifications to a higher level to the benefit of the sport (eq to gain an instructor qualification).

Applicants for these grants must hold British Citizenship and be permanently resident in UK and aged 14-21 years (Advanced) Bursary - 24 years). Safety

Trial Lessons / Introductory Flights. A trial lesson is a paid-for first or early instructional flight. An introductory flight is a paid-for gliding experience flight. Clubs and pilots must minimise risk during introductory flights and trial lessons as well as during other passenger flying. Clear guidance on how to minimise the risk during trial lessons and introductory flights is provided in the BGA's Managing Flying Risk publication.

Winch Launching. A recent winch launch failure resulted in the drogue parachute landing outside the airfield boundary resulted in no damage or injury. The thorough local investigation highlighted the need to ensure satisfactory club procedures and practice in correctly positioning winches, decisions on when and when not to operate in crosswinds, regular checks of launching equipment, and training in drift correction during the launch. GPS Software. A recent incident where a delivery driver crossed a runway has resulted in a Club Safety officer recommendation that BGA clubs may wish to check whether commonly used Sat Nav software could direct drivers to cross their operating areas. In this case, the club is taking action to ensure that drivers using GPS are routed correctly.

Club Safety Review. Clubs are reminded that a Club Safety Review is an opportunity for both the responsible club committee and those supervising flying to reflect on club operations and associated hazards. https://members.gliding.co.uk/library/safety/club-safety-review-guidance/

This workshop will look at the emerging specification, what elements are already there, what gaps we need to fill to deliver the UK Glider Racing platform - and how we might start to do it. Airspace

Oxford Airport and RAF Brize Norton Airspace Change Consultations. As anticipated, Oxford and Brize Norton have published their individual airspace change proposals. These proposed changes are being developed under the discredited CAP 725 requirements rather than the CAP 1616 requirements which came into force on 2 Jan 2018. There is little doubt that these two disproportionate airspace change proposals pose a very significant threat to the viability of gliding and other recreational aviation in and through the area, and will significantly increase risk for the majority of airspace users operating outside of the proposed airspace. Exeter Airspace Change Proposal. On 15th December, Exeter airport submitted its post consultation report and proposal for a huge area of controlled airspace to the CAA. This proposed change is being developed under the discredited CAP 725 requirements rather than the CAP 1616 requirements which came into force on 2 Jan 2018. The response fails to take into account GA stakeholder consultation inputs. 8.33 Data. The CAA intends to provide updates of airfield frequencies as they convert to 8.33 kHz frequencies during 2018. The first version of a supplement will be published during mid-February along with a NOTAM and will be updated on a weekly basis. An initial version is available under 'Updates' on the CAA's 8.33 webpage.
