4 Juniors' update

- Matt reported that the Lasham comp organisation was progressing well, 39 entries to date, he's expecting a well run competition which will require lower funding than normal.
- Budgeting / comp management guidance as written by Poz has been given to Gavin.
- Matt is looking for new members for the JCG from the pool of those current/more recently Juniors – Comps committee advised open advertisement for positions and to broaden demographic and geographic representation as far as possible.
- 'Summer Series' of training weekends has been arranged by Matt Page and Pete Hibbard to pick up Juniors in the 'post solo gap'.
- There was a good and well attended Junior Gliding meeting at the BGA Conference which looked at improvement opportunities.
- Navboys sponsorship it has proved difficult to engage both juniors and the sponsorship organisation sufficiently to meet the target return on investment; lesson learned that it is vital to document the agreement properly and ensure structured follow up. Matt is currently putting a detailed plan together with Shaun and Poz and this will reflect Navboys' sponsorship of Junior Gliding as a whole rather than just the Junior Nationals. The intention is that people will be able to work for sponsorship and will only get support on this basis. CC supported this approach.

- Liz asked that this agreement goes to the Sponsorship Working Group as soon as drafted; in discussion we agreed that it's vital to have a written document outlining expectations of both sides and that the lack of this had been an issue.
- Matt noted that one issue had been the fact that Junior Gliding does not exist as an entity. Liz
 advised that any agreement should be with the BGA via our chain of governance through Comps
 Committee, Junior Comp Group, Sponsorship Working Group she pointed out that BGA office
 happily maintain 'separate' accounting of money for eg Womenglide and Juniors

5 Interclub League update

- Liz updated the meeting with outcome of the BGA conference workshop which had not been well advertised and unfortunately didn't appear in the conference programme we posted handwritten posters around the conference.
- ICL is becoming more popular more leagues this year: Southwestern, Rockpolishers, Midland, East Midland, Scotland, Northern, Eastern, Yorkshire (1 date only)
- Russ Morriss from Peterborough and Spalding attended; they were invited to join the Eastern league.
- The workshop agreed the need for both local rules to suit the level of experience of local club pilots and national rules for the final
- Query remains over location of final if Scottish league will come south, to be held at Sutton Bank, otherwise to move to a more central location.
- All leagues encouraged to operate a non-scoring 2-seater class to give inexperienced pilots XC opportunity; recognised this is not easy for some clubs.

6 TP Review

- Iain reported that the TP review was nearly complete; some final work needed to resolve points around Cheltenham/Staverton approach plus a request from Cairngorm GC.
- Cairngorm had requested renaming some TPs in a way that is not in accordance with the published naming convention which is to name TPs after placed on the half-mill and then quarter-mill maps. Cairgorm's recommendation was to name the places after their actual village names which do not appear on airmaps, noting that this is what the places are known as to locals and visitors alike. Ian Strachan and Tim Newport-Peace who maintain the list are strongly against the proposal, seeing it as a 'thin end of the wedge' on naming and leading to confusion to pilots from elsewhere. Comps committee could see both perspectives, and concluded that perhaps the issue was that the naming convention which has been in place since before Google maps etc etc needed review. Meanwhile CC support the change in line with Cairngorms request we have consulted and shouldn't ignore feedback.

8.1 Year-2 Proposals

8.1.1 Change of the 1000 Point Distance Requirement (Annex A Committee) agree

Proposal to change minimum distances to:-

13.5 Metre and Club class 250 km

Standard, 15 Metre, and 20 Metre Multiseat classes 300 km

18 Metre and Open classes 350 km

8.1.2 Definition of Silver distance (Sweden)

It is proposed to change the wording from "a straight distance flight of at least 50 km from the release point" to "a straight distance flight to a way point that has a distance of at least 50 km to both the release point and the launch point".

This could be OK if we can define a start point rather than the launch point. Amend to go back to 2014 wording allowing any 50k leg

8.1.3 Move of FR technical requirements from SC3 (SC3 Committee)

To replace the current 2 year process for changes of technical requirements for flight recorders in SC3 with the following process:

1. Bureau or GFAC makes a request for a change in the rule. In the event that GFAC is requesting such a change, the Bureau must approve the request

Agree as long as they keep to technical changes only.

A procedure when the glider has an FR that is not being used for the record.
