

An infrequent update from the Development Committee

1. Club Management Resources review

I am currently reviewing and re-writing (where required):

As part of this work, I am currently running the 6 session 'Project Planning (and Funding) Training online via Zoom and will shortly be running 'Effective Club Management Training' in reality at 6 clubs around the country. This work should be completed by the middle of July.

I will re-run the online Project Planning Training periodically, at a different time of the week for each re-run.

4. SLACK – avoiding wheel re-invention for busy people

There is a group called 'BGA Gliding Group' which has a number of channels for a range of roles and topics. It is a space where we can post information, but more importantly it creates a place for you to ask questions and have discussions with other clubs.

5. Data Protection and GDPR

A few clubs have used the <u>GDPR Survey Monkey</u> to let us know about issues. The survey remains open so you can still use it.

I've also had a couple of random questions, which makes me think I ought to post the link to the <u>Data Protection information on the BGA website</u>. This has the information and guidance which the BGA published last year, which contains the links to the <u>sport specific GDPR</u> information put together by GDPR experts (funded by Sport England, facilitated by the Sport & Recreation Alliance).

Just a reminder, we're all volunteer-run, non-profit organisations (of less than 250 employees) which lightens obligations a little, so no Data Protection Officers for us, for example! However, the biggest threat remains accidental data leakage via human error, so please pay attention, especially to odd links in emails and at committee succession time.
